Following Mr. Riffle's recommendation, Mr. Miller made a motion to approve Status Quo Teacher Contracts. It was followed by a second from Mr. Rettinger, and the motion carried 4-0. Mr. Stichter moved to approve the resignation of Alvin Chupp as Crossing Guard, the employment of Janis Kaufman as Elementary 2nd Shift Custodian, Jared Bules as Computer Technician, Casey Yarbrough as Afternoon Crossing Guard, and Alvin Chupp as Substitute Crossing Guard, Mr. Miller seconded, and the vote carried 4-0. Mr. Stichter moved to approve Kassandra Summe as 7th Grade Volleyball Coach and Meriuh Hoffert as Junior High Cheer Coach, Mr. Rettinger seconded, and the vote carried 4-0. Mr. Miller moved to approve Lisa Bemish as High School Cross Country Supervisor, Rachel Watkins as Fall Weight Room Supervisor, Megan Hammond as Varsity Volleyball Supervisor, Jason Groves as Varsity Football Supervisor, and Diane Murphy as Junior High Volleyball Supervisor, Mr. Rettinger seconded, and the vote carried 4-0. Mr. Miller motioned to approve the security agreement with The Town of Bourbon, Mr. Rettinger seconded, and the motion carried 4-0. Mr. Stichter moved to approve/accept the 24/25 Triton Jr./Sr. High Financial Report as well as the 24/25 Triton Elementary Financial Report, Mr. Miller seconded, and the vote carried 4-0. Mr. Stichter moved to approve the First Reading of Policy Volume 37, No. 2 April 2025 and to adopt the Special Update Policy July 2025, Mr. Rettinger seconded, and the vote carried 4-0. Mr. Rettinger moved to approve the 25/26 Food Service Bid Recommendations, Mr. Stichter seconded, and the vote was unanimous.

Superintendent's Report
